In continuation of our newspaper advertisement dated 26th August, 2023, NOTICE is hereby given that the 52nd Annual General Meeting ("AGM") of BSL Ltd ("the Company") will be held on Thursday, the 28th day of September, 2023 at 04:00 P.M. through Video Conferencing ("VC")/Other Audio-Visual Means ("OAVM") to transact the Ordinary and Special Businesses as set out in the Notice of the 52nd AGM without the physical presence of the members at the

venue. The deemed venue for the AGM shall be the Registered Office of the Company at 26, Industrial Area, Gandhi Nagar, Bhilwara-311001, Rajasthan. The Ministry of Corporate Affairs ("MCA") has vide its circular No. 10/2022 dated December 28, 2022 in furtherance of its earlier circulars (Circular No. 14/2020, 17/2020 and 20/2020 dated April $8^{\rm th}$, 2020, April $13^{\rm th}$, 2020, May $5^{\rm th}$, 2020 respectively and subsequent circulars 02/2021, 21/2021 and 02/2022 dated January $13^{\rm th}$, 2021, December $14^{\rm th}$, 2021 and May $5^{\rm th}$, 2022 as also the

January, 2023, (read together with Circulars dated 13th May, 2022, dated 15th January, 2021 and dated 3th May, 2020) (collectively referred as "Applicable Circulars") permitted the holding of AGM by the Companies through Video Conferencing/Other Audio Visual Means ("VC/OAVM"), without the physical presence of the members at the AGM venue. In compliance with these Applicable Circulars, the 52nd AGM of the Company shall be conducted through VC/OAVM without the physical presence of the members at the AGM venue. Hence, Members can attend and participate in the AGM through VC/OAVM only. The instructions for joining the AGM will be provided in the Notice of AGM. In compliance with the Applicable Circulars, the Notice of the 52nd AGM and the Annual Report of the Company including audited financial statements for the financial year 2022-23 along with Director's Report, Auditor's Report and other documents required to be attached

thereto, have been sent on 1st September, 2023 through electronic mode to the members of the Company whose email addresses are registered with the Company /Depository Participant(s). The requirements of sending physical copies of the Notice of 52nd AGM and

Instructions for remote e-voting and e-voting during the AGM: Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended), Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015 (as amended)

and the Applicable Circulars, the Company is providing facility of remote e-voting/as well as e-voting during the AGM to its Members to cast their votes electronically in respect of the business to be transacted at the AGM as set forth in the Notice of 52nd AGM provided by National Securities Depository Limited (NSDL) as the authorized agency. The manner of e-voting for shareholders holding shares in dematerialized mode, physical

The Register of Members and Share Transfer Books of the Company shall remain closed from Friday, the 22nd September, 2023 to Thursday, the 28th September, 2023 (both days inclusive) for annual closing and for determining the entitlement of the shareholders to the dividend for the financial year 2022-23 as recommended by the Board of Directors of the Company, if declared by the members at the AGM. Members holding shares either in physical form or in dematerialized form, as on the cut-off date of 21st September, 2023, may cast their vote electronically. A person whose name is recorded in the Register of Members or in the Register of beneficial owners maintained by the depositories as on the cut-off date i.e. 21st September, 2023 only shall be entitled to avail

the facility of remote e-voting as well as voting at the AGM. The remote e-voting period commences on Sunday, the 24th September, 2023 (9:00 A.M. IST) and ends on Wednesday, the 27th September, 2023 (5:00 P.M. IST). The remote e-voting module shall be disabled by NSDL for voting thereafter. The remote e-voting shall not be allowed beyond the said date and time.

The Members, whose names appear in the Register of Members/list of Beneficial Owners as on Thursday, 21st September, 2023, i.e. the date prior to the commencement of book closure, will be paid the Dividend of Rs. 1.5/- (15%) per Equity Share of the face value of Rs. 10/- each for

the financial year 2022-23, as recommended by the Board, if declared at the 52^{nd} AGM of the Company, within 30 days from the date of AGM. The voting rights of the members shall be in proportion to their share in the paid up equity share capital of the Company as on the **cut-off date i.e. Thursday**, 21st September, 2023.
